Who Needs a KCMO Pet License?

Kansas City Missouri law requires all dogs, cats, and ferrets over 4 months old and kept within the City limits to have a current license. Furthermore, license tags are to be worn by the animal when outside the residence. Violators can be cited for failure to comply with a minimum \$75.00 fine for the first offense.

What Are the Benefits of Pet Licensing?

- · A license tells everyone your pet is not a homeless stray.
- Found pets can be reunited quickly with their owners.
- · Your lost pet gets a longer care period when taken to a shelter.
- Your pet license is proof your pet has been vaccinated against rabies.
- License fees support the care for the many stray and homeless animals housed in the City's animal shelter. Other services funded by pet licensing include investigations of animal cruelty, animal bites, animal nuisance complaints, and education and outreach programs.

How Do I License My Pet?

By Mail: Mail a copy of your pet's current **rabies vaccination certificate**, complete with your mailing address and phone number, along with a **check or money order** made payable to "City Treasurer". Send to:

In Person: Take a copy of your pet's current rables vaccination certificate and proof of the pet's sterilization (if applicable) to a local participating veterinary clinic. Call or visit PetData's website for a list of participating veterinary clinics. You can also purchase a license at Kansas City Animal Health & Public Safety. Call AHPS for shelter hours.

NEWSLETTER MINUTES

The board convened at 5:30 p.m. Present were Sheila Johnson, president; Ann Halsey, first vice president; Mike Crippen, second vice president; Betty Maltbia, treasurer; Selma Irey, secretary; Elizabeth Tharp, office manager; Shanna Tait, assistant office manager; Les Dudrey, maintenance superintendent; and Lisa Gamble, controller for Linville Management Services, Inc.

Lisa said the cost to double security patrols from three to four a night to seven to eight a night would be \$1,400 -- twice as much as the cooperative is now paying.

The mortgage payoff party was tentatively scheduled for April of 2010.

Open Session

Fourteen people signed in for the meeting. Sheila welcomed them and called the meeting to order at 7:10 p.m.

Minutes of the June 23 meeting were approved.

Betty gave the treasurer's report. She has reviewed receipts for June and all are in order. There is only one mortgage left to pay off; four have already been paid.

Selma reported that three installation permits were approved.

Elizabeth gave the office report. There have been 37 recertification's sent out; 59 units have been exterminated. Eight one-bedroom units are available with no wait list and two three-bedroom units are available with a wait list.

The office has been sending reminders out to members about missing pet information such as vaccinations and Kansas City pet license numbers.

Les gave the maintenance report. There were 241 work orders completed. Maintenance is working on six rehabs.

The slab should be poured on July 15 at 5357 and 5359 N.E. 37th. Les is working with a laboratory, a plumber and Kansas City officials to determine the source of water at building #6.

Sheila opened the floor to member concerns.

Wasteful and excessive water use was discussed. Elizabeth was asked to publish in The Brightoneer the cost for water usage in June.

Converting one-bedroom units to ground-level entries was suggested as a way to accommodate the needs of more members. This could be accomplished by pouring a sidewalk to the backdoor for entry. Les said it could be done with at least two of the one-bedroom units.

Members also expressed their appreciation for the quiet 4th of July.

Kevin Johnson won the door prize drawing, a prepaid card to QuikTrip.

Sheila thanked everyone for attending and the open session ended at 7:40 p.m.

Closed Session

Les was asked to put identification on the North Brighton maintenance trucks.

The meeting was adjourned at 8:20 p.m.
