NEWSLETTER MINUTES

The board convened at 5:30 p.m. Present were Sheila Johnson, president; Ann Halsey, first vice president; Mike Crippen, second vice president; Betty Maltbia, treasurer; Selma Irey, secretary; Elizabeth Tharp, office manager; Les Dudrey, maintenance superintendent; Lisa Gamble, controller with Linville Management Services, Inc.; and Dudley Leonard, cooperative attorney.

The board reviewed and approved four transfer applications.

Elizabeth was asked to change from ``25%'' to ``50%'' on the application so that it reads: ``Your actual income must not be so minimal as to cause more than 50% of your total income to go toward payment of carrying charges.

Open Session

Sheila welcomed members and called the meeting to order at 7:10 p.m. Fifteen members signed in. Sheila introduced the head table.

The minutes of the May 12 meeting were approved as written.

Betty said that she had reviewed the receipts for April and May and all were in order.

Selma reported that 14 installation permits were approved. She summarized the work covered by the permits.

Elizabeth gave the office report. For June, 37 recertifications were sent out and 56 units were exterminated. There have been two move-ins and four members have submitted transfer applications. There are three one-bedroom units for sale with no wait list and three three-bedroom units available with a wait list.

Les said the concrete slab has shifted and the jungle gym behind 5319 N.E. 36th is no longer safe. The board reviewed photos of the jungle gym and voted unanimously to have it removed.

Les presented bids for concrete removal and replacement at 5359 to 5357 N.E. 37th Street and the board voted unanimously to accept a bid from Hodges Garages.

A new contract negotiated with Amark Uniforms will result in a savings of 25 percent, or some \$2,000 to \$2,500.

Maintenance has begun working on bringing satellite and cable installations in compliance with specifications.

Damaged and squeaking hardwood floors in one of the units were replaced by maintenance at a cost of \$1,900, compared with \$5,000 for the same work done by a contractor.

The board voted to ratify a telephone taken on May 29 to accept a bid from Pier Magic for eight piers at 5359-5357 N.E. 37th St.

Sheila opened the floor to member comments. The transfer application process, property damage and destructive behavior by cooperative youth, a bicycle theft, curfew and inadequate drainage were discussed.

Denise Miller of 5355 N.E. 37th won the door prize drawing, a prepaid card to QuikTrip.

Sheila thanked everyone for attending and the open session ended at $8:10\ \mathrm{p.m.}$

Closed Session

The board voted to allow satellite or cable to enter the front of a unit through an existing cable hole or by a hole drilled through the foundation in front of the unit if there is no cable access. Drilling through shingles will not be allowed.

Sheila and Selma signed the audited financials of 12/31/08 prepared by Darel D. Kyle, certified public accountant. Lisa distributed copies of the audit to board members.

The meeting was adjourned at 9:25 p.m.
