



Maintenance Reminders

Rules We Live By Section 6.4 Regulations (A)



Removal and disposal of animal waste is the responsibilities of the pet owner. Pet waste must be removed daily from the grounds and placed in a sealed or tied container before being properly disposed of in a trash receptacle.



Fence Inspections:

1. Fences need to be painted if rusted.
2. Top rails need to be replaced or straightened if bent or damaged.
3. Gates need to be repaired or replaced if damaged or broken.

Check your fence today to save yourself from being tagged.



Section 2.3 Curfew

No minor under the age of eighteen (18) shall loiter, wander, stroll or play in or upon the streets, parks, playgrounds or other property of NBT between the hours of 11:00 p.m. on any day and 6:00 a.m. of the following day; provided, however, that on Fridays and Saturdays the effective hours are between 12:00 midnight and 6:00 a.m. The provisions of this rule shall not apply in the following instances... Members who violate yard-keeping standards will be notified of the violation and allowed ten (10) days to comply. Three separate violations of grounds rules within a 12-month period will result in a grievance hearing.
