Bob Guimbarda and Gwen Knight of EVS joined the meeting at 6:10 p.m.

Open Session

Eight members signed in for the open session. Betty welcomed them and called the meeting to order at 7:15 p.m.

Minutes of the February 8 board meeting were approved unanimously.

Selma said 10 installation permits had been received and approved.

Terry gave the treasurer's report. She has reviewed the receipts and found all in order.

Elizabeth gave the office report. Nineteen units are for sale: five one-bedroom units, 10 two-bedroom units and four three-bedroom units. There is a \$150 referral fee paid to members who refer a qualifying applicant.

A new furnace and air conditioning system has been installed in the club house.

Betty opened the floor to member comments.

Margo Stotts asked that mowing of the grounds cease while children are waiting for the school bus.

Connie Kanatzar won the \$25 gas gift card.

Closed Session

Les was asked to investigate current vertical and horizontal shed sizes.

Dudley was asked to write a towing rule.

The board ratified four telephone polls.

The board reviewed nominations for the Good Neighbor award and an April recipient and a May recipient were chosen.

The board discussed habitual violations of North Brighton yard keeping standards by members whose backyards are continually full of debris and trash. Grievance hearings for such violators will be scheduled upon documentation and recommendation by maintenance staff. Three separate violations of the grounds rules within a 12-month

period will warrant a grievance hearing.

The board approved the purchase of two smaller tables to replace the big table in the board room.

The board voted to discontinue advertising on Apartment. com.

The board agreed to change security patrol hours during the summer.

Board members were asked to review and sign the board member code of ethics.

The meeting was adjourned at 11 p.m.
