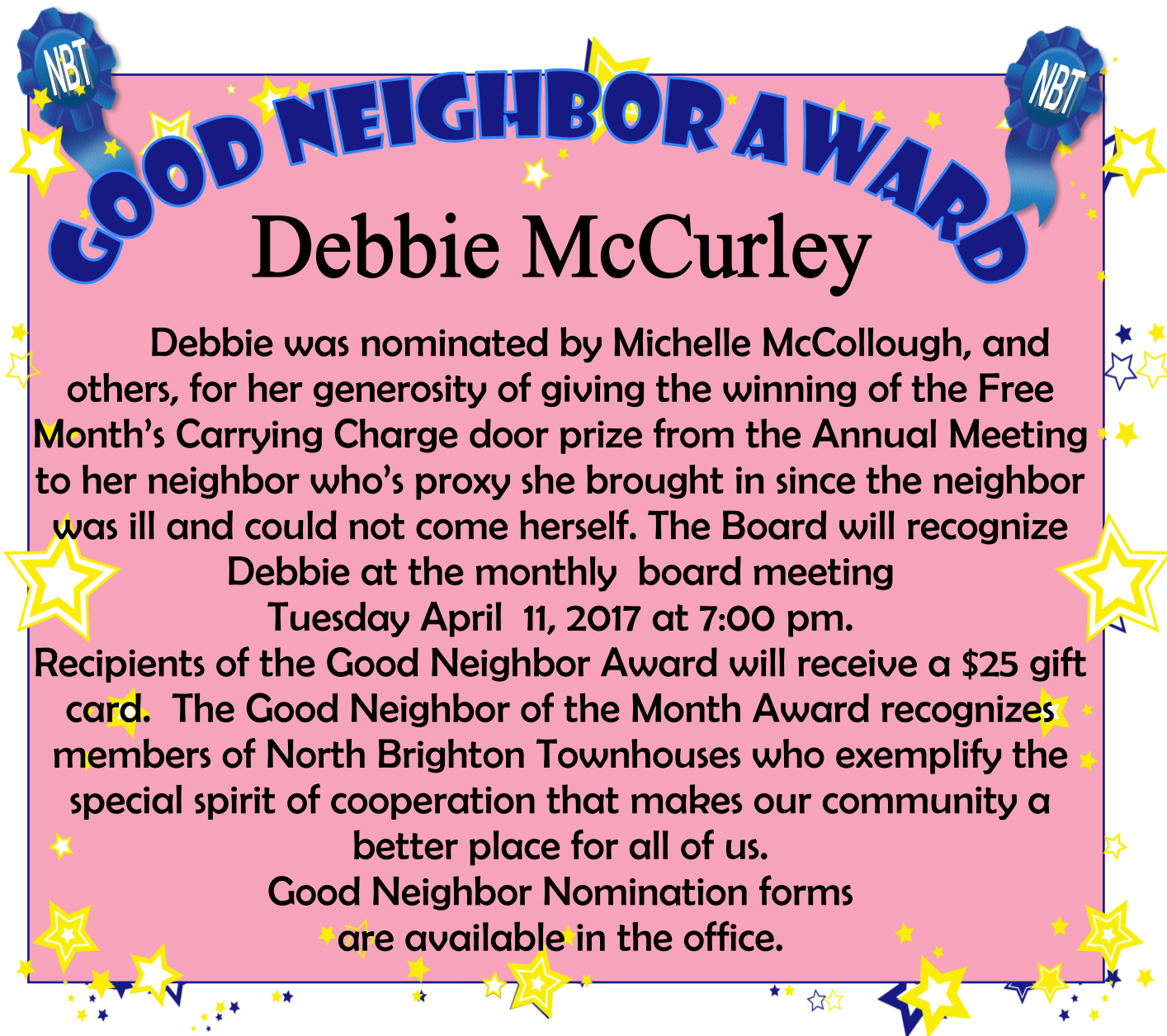

Board members present: Selma Irey, president; Sheila Johnson, first vice president; Ann Halsey, second vice president; Dorothy Olson, treasurer; and Esther Shelton, secretary

Staff members present: Elizabeth Tharp, office manager; Sherri Ladd, assistant office manager; Les Dudrey, maintenance superintendent; and Chris Curlett, assistant maintenance superintendent

Also attending: Melva Linville, property manager, and Betsy Kilker, administrative assistant, with Linville Management Services, Inc.; and Dudley Leonard, cooperative attorney

Selma Irey, president, welcomed members and confirmed with Elizabeth Tharp that a quorum had been met. Seventy-three members were present in person or by proxy.

Selma called the meeting to order at 2 p.m.

Selma referred to the letter about the annual meeting and election mailed to all member households as proof of notice.

Minutes of the March 13, 2016, annual meeting were approved by acclamation.

Elizabeth gave the office report. In 2016, there were 37 move-outs, 43 move-ins and three transfers. Of the move-ins, 24 were due to member referrals.

Currently, six memberships are for sale: two one-bedroom units, one two-bedroom unit and two three-bedroom units.

The North Brighton Website is now mobile-friendly. There are 128 members using the portal; 578 cars registered on the property; 224 pets registered; 998 people registered.

Of these 998, 286 are children 18 years old and younger; 117 are adults 65 years old and older.

Les gave the maintenance report. In 2016, 1,650 work orders and 37 rehabs were completed. Maintenance currently is working on seven

rehab. Gutters have been cleaned out.

Melva gave the managing agent's report. She reviewed handouts distributed earlier that show the breakdown of how carrying charges were spent; assets of \$14,456,452; and reserves of \$2,170,726.

Selma announced that there were two three-year positions open on the board. She and Dorothy Olson have filed for re-election.

Selma asked for nominations from the floor. There were no nominations from the floor. The members voted by acclamation to close the nominations.

The members voted by acclamation to elect Selma and Dorothy to the board.

Door prizes were drawn. Sharon Cross won a month's free carrying charges. Nicole Stoneking and Debbie McCurley won \$50 cash prizes each. Edna Calumpong won a \$25 gas card.

The open session ended at 2:35 p.m.

The board met in closed session. The meeting was adjourned at 3:10 p.m.

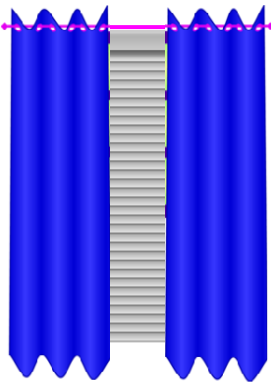

Office News



There have been several calls made to the office about dog waste being left in members' yards. Pet ownership is a privilege: it is the responsibility of the owner to clean up after their pet. To file a complaint about someone walking their dog and not cleaning up after it, you only have to know their address, not their name.



Section 1.1 Housekeeping Standards

General

4. Windows should be clean and must not be nailed shut. All windows must have acceptable window coverings at all times when living in unit. Acceptable coverings include blinds, shades, vertical blinds, curtains, drapes. Shades or blinds should be intact.

**Broken blinds, sheets or blankets are not acceptable.*

Maintenance Reminders

The stoves on the property are not designed to have the top lifted to be cleaned. Lifting the top can cause damage to the gas feed lines and the repair will be charged to you. There have been cases where the entire stove had to be replaced at the member's expense.



Please make certain that all trash is placed inside the dumpsters. It is not acceptable to leave bags of trash beside or on top of the dumpster. Thanks for your cooperation.



Mowing Crews are on the property. Please make sure all toys are picked up from the common areas, including your front yard.

Rules We Live By: Pets—Section 6.4 Regulations

- A. When outside a fenced yard, all pets must be leashed, restrained and under the control or supervision of the member. Pets cannot threaten others by attempting to bite, jump upon, charge toward or otherwise cause others to fear immediate personal injury to themselves, to other people or to their own pets.

Removal and disposal of animal waste is the responsibility of the pet owner. Pet waste must be removed daily from the grounds and placed in a sealed or tied container before being properly disposed of in a trash receptacle.

- B. If a North Brighton employee meets with an animal control officer to correct a violation of North Brighton's rules or city ordinance, a fee will be charged to the pet owner's account.
- C. No person may keep or harbor any animal on the premises of North Brighton without a current Pet Permit.
- D. The owner of a pet will be held financially responsible for any actions of such pet. In addition, the owner agrees to totally accept all liability pet ownership may create.

Grounds Inspections Have Begun



Do Not wait to be tagged to mow your yard or pick up pet waste, clean your yard and call one of the lawn mowers to cut your grass. See page 11 for their names and numbers. If you get tagged to clean or mow your yard, you have only a few days to comply. Calling the office will NOT allow you more time. Maintenance will charge a minimum of \$35 to mow. If you are tagged 3 times, you will be called in for a grievance before the board of directors.

RulesWeLiveBy: Section 2.8 Yard Sales

YARD SALES

Members are allowed to have their own sales from May through September only.

The following rules apply:

- 1) Signs must be removed from the property the morning after the sale is over.
- 2) All merchandise must be brought inside the unit each night if member is having a multiple-day sale.
- 3) Multiple day sale are limited to (3) three days.
