


Catherine Ann Halsey 1935-2018

The proper procedure is: Shut water off underneath your kitchen sink (or some are located in the utility room), then disconnect the water hose and open the faucet valve outside. Allow the faucet to drain then leave the faucet on. If this is not done, it can freeze and burst the pipe inside the wall and member will be responsible for the repair.

We want to thank everyone for your cooperation during the seal-coating and restriping of the parking lots.

We know it was an inconvenience but it was badly needed. We had to tow only a few vehicles.



With the time and expense put into the new seal-coating and striping of the parking lots, we will be more diligent

tagging vehicles that have oil or antifreeze leaks. Several areas have been noted and will be checked weekly. If your vehicle has any kind of leak, now is the time to get it repaired. If your vehicle leaks and damages the new seal coating, you will be charged for the repair of the damaged area.

Rules We Live By: Section 1.9 Vehicles

- A) One car per licensed driver per household.
- C) Entire vehicle must be parked between the yellow lines provided. Motorcycles and motor scooters must be parked parallel to the sidewalk in member's numbered space along with member's other vehicle. Vehicles parked over yellow lines or double parked may be tagged or towed at the owner's expense.
- K) Members may be charged for clean-up of oil leaks caused by their vehicles.

Are you getting unwanted calls or junk mail? **Tips from the MO Atty. General**

Here are some tips to keep in mind when answering a call from an unknown telemarketer:

☐ If you receive telemarketing calls, do not provide personal infor-
mation such as credit card number or social security number. Only do
so with companies that you know and that you call directly yourself.
☐ Often times, automated recordings have messages like "Press 1 for
more information, or press 2 to be removed from our list." Do not
push any number. All this does is confirm that your line is a working
number.
\square When you are at a store and the person at the register asks for your
phone number, say "No thank you." Stores usually do not need this
number to process your credit card and are instead asking for your
phone number so they can call you or sell your number to telemar-
keters.
☐ Similarly, do not provide your phone number when entering con-
tests. They also sell your number to telemarketers

If you want to curb delivery of unsolicited mail to your home from national companies, write to:

> Mail Preference Service **Direct Marketing Association** P.O. Box 643 Carmel, NY 10512 www.dmachoice.org

You can write: "The undersigned requests that his or her name be removed from any and all mailing lists for unsolicited mail being delivered to:" Include your name, address, and names of others in your household requesting this service. (If you continue to receive mail three months after sending the postcard, write directly to the mailers to request removal of your name from their mailing lists.)
