
The Board of Directors will recognize Delia at the board meeting on February 11th, 2020.

Processed during the month of November was \$191,018.53 in accounts payable and in December, \$192,914.77.


Financial reports for November and December have been delivered to the board.


Reason for Candidacy: I feel I can contribute something useful to the board and want to continue to do all I can to make North Brighton an affordable and great place to live.
