North Brighton Townhouses, Inc. March 8, 2020 Annual Meeting

Board members present: Selma Irey, president; Mike Crippen, treasurer; Dorothy

Olson, first vice president; and Willia Bailey, second vice president

Board member absent: Esther Shelton, secretary

Staff members present: Elizabeth Tharp, on-site manager; Tonilynn Shoff, assistant manager; Les Dudrey, maintenance superintendent; and Chris Curlett, assistant maintenance superintendent

Also attending: Mike Lauer, regional manager for Tailor Made Property Services, and Brad Constance, cooperative attorney

Selma Irey, president, welcomed members and confirmed with Elizabeth Tharp that a quorum had been met. Eighty-three members were present in person or by proxy.

Selma called the meeting to order at 2:18 p.m.

Selma referred to the February 21, 2020, letter about the annual meeting and election mailed to all member households as proof of notice.

Minutes of the March 10, 2019, annual meeting were approved.

Elizabeth gave the office report. In 2019, there were 20 move-outs, 26 move-ins and four transfers. Of the move-ins, 17 were due to member referrals.

Currently, two memberships are for sale: one one-bedroom unit and one three-bedroom unit.

Les gave the maintenance report. In 2019, 2,167 work orders and 27 rehabs were completed. There were 11 bed bug cases in the first six months of 2019 and none in the last six months.

Daily trash pick-up costs the cooperative \$7,500 a year.

Preventive maintenance to be performed includes roof inspections and repairs, minor street repairs, gutter cleaning, tree trimming, concrete repair, sewer mains (\$27,000), handrail repair and painting and adding playground mulch.

Mike Lauer gave the managing agent's report. He reviewed handouts distributed earlier that show the breakdown of how carrying charges are spent and cooperative assets of \$14,564,038 and reserves of \$2,604,355.

Selma announced that there were two three-year positions and one two-year position open on the board. Candidates are James Franklin, Betty Maltbia, Sheila Johnson, Willia Bailey and Selma Irey.

Selma asked for nominations from the floor. There were no nominations from the floor. The members voted by acclamation to close the nominations.

The candidates addressed the members.

Volunteering to serve as inspectors of election were Diane Schumacher, Steve Stotts and Heather Tharp.

Roll was called and ballots distributed. Brad and the election inspectors left to count ballots at 2:45 p.m.

Selma recognized Dorothy Olson, retiring board member, for her service on the board.

Autumn Gabriel was recognized as the Good Neighbor of the Month for March.

Brad and the inspectors returned at 3:10 p.m. Willia Bailey won 71 votes; Sheila Johnson, 55; Selma Irey, 54; Betty Maltbia, 43; and James Franklin, 23.

Door prizes were drawn. Bonnie Ross won a month's free carrying charges. Willia Bailey and Cheryl Spring won \$50 cash prizes each. Magda de la Paz Diaz won a \$25 gift card.

The annual meeting ended at 3:20 p.m.

The board met in closed session. The meeting was adjourned at 4:05 p.m.

- Air conditioner not working, when it creates a health menace to member or the household, or outside temperature exceeds 90 degrees F.
- Commodes in one-bedroom units inoperable.
- Hot water tank inoperable.
- Electrical or plumbing problems that cannot wait until next business day.
- Sewer back-up.
- Lock-outs.
- Broken windows (not merely cracked), under severe weather conditions or extreme circumstances.
- · Refrigerator stops working.

Friendly reminder, please only flush waste and toilet tissue down the toilet.

No Flushable wipes or paper towels this will help prevent a sewer back-up.
