

Three final statements were completed and two are pending.


In September, Tailor Made processed \$202,335.99 in accounts payable.

#### Maintenance Reminders

#### Things to know:

- \* Please do not flush anything but waste and toilet paper down the toilet, there has been an increase of back up due to wipes being flushed.
- \* As it gets cooler outside, outside faucet should be turned off at first frost.

  Procedure: Shut off water underneath your kitchen sink (some are located in utility closet). Disconnect the water hose, open the faucet valve outside. Allow faucet to drain then leave the faucet on. If this is not done, it can freeze and burst the pipe inside the wall. The member will be responsible for repair!
